





On Thursday, October 1, 2015 at 1531 hours, I was dispatched to the intersection of Meeker Road and Dog Leg Road located in Butler Township, Montgomery County, Ohio, for a property damage crash.

Upon my arrival at 1535 hours, I observed a blue Chevrolet Metro bearing Ohio registration GLF8023 parked on the grass on the southeast corner of the intersection. I also observed a silver or grey Ford F-350 pickup bearing Ohio registration FJR2538, which was pulling a black trailer bearing Ohio registration TPG2254, that was parked along the southbound side of Dog Leg south of the intersection. I asked if anyone was injured and all parties stated no.

I identified the driver of the Metro as Victoria L. King via her Ohio Driver License and her passengers as Joe M. Shackelford and Joella L. Shackelford. I identified the driver of the F-350 as Matthew M. Lowe via his Ohio Driver License and his passenger as William B. Holbert. I obtained witness statements from all adults involved.

All witnesses agree that the F-350 was traveling southbound on Dog Leg Road and the Metro was traveling westbound on Meeker Road. The Metro stopped at the stop sign and then proceeded to turn left (south) onto Dog Leg Road without yielding to the F-350. The Metro pulled into the southbound lane in between the F-350 and the trailer and was struck on the front right side by the front left side of the trailer.

I took ten digital photographs of the scene. I issued King citation 41823 for failing to yield after stopping at the stop sign. I completed an exchange of information sheet and provided each driver with their copy.


