



On Friday, October 2, 2015 at 0816 hours, I was dispatched to the Buckeye EcoCare located at 8617 North Dixie Drive in Butler Township, Montgomery County, Ohio for private property hit and skip crash.

Upon my arrival at 0823 hours, I made contact with the complainant, Matt Dixon, who gave me his report. Dixon reported that upon arriving at work he noticed that the gas tank encased in a concrete open top box near the southeastern corner of the building had been struck and moved south approximately six inches.

Dixon reported that he entered his office and reviewed the security camera footage. Dixon found that on Friday, October 2, 2015 at 0528 hours, a late 1990's Honda Odyssey minivan came within the view of the security camera located near the southeastern corner of the building. The van apparently attempted to drive between the building and the wood line. The van left the camera's view and apparently stopped.

The van reentered the camera's view when it reversed. The van reversed slowly at first and then accelerated rapidly prior to hitting the gas tank and drove it back approximately six inches. The back glass of the van shattered. The van pulled forward and left the camera's view.

Dixon stated that the gas tank sustained damages in the amount of \$200.00. The physical damage that I saw was an electrical conduit was broken. The conduit provided electricity to the gas pump.

I recorded the playback of the security camera footage. I took six digital photographs of the scene.
