



On Sunday, October 4, 2015 at 0732 hours, I was on patrol in the area of Frederick Pike and Old Springfield Road in Butler Township, Montgomery County, Ohio, when I observed that the stop sign for the Frederick Pike northbound lane at this location had been knocked over.

Upon inspection, I observed the road sign to Old Springfield Road to be on the ground in the area as well. I was able to see that the P&G truck deliveries signs were bent in a fashion that would be consistent with a vehicle traveling westbound on Old Springfield Road and then turning left to travel southbound on Frederick Pike. The height of the signs that were still on the DP&L pole they are attached to, suggests a larger box truck or semi trailer was the vehicle that had made contact and side swiped the property.

I did not locate any other evidence from the crash, and it is not known when exactly the crash occurred. I took photographs of the scene.

I had dispatch contact he Montgomery County Engineer's Office, and the stop sign was replaced in the ground for traffic control.
