





On Tuesday, October 13, 2015 at 1511 hours, I was dispatched to the Butler Township Police Department of a report of a witness reporting a hit & run crash.

Upon my arrival, I met with the witness who was identified as Tim Severance, who resides in Butler Township.

Mr. Severance stated that around 1410 hours on today's date, he observed a vehicle that he described as "driving erratically" on Yorkshire Drive. Mr. Severance said he followed the vehicle onto Fernside Court and witnessed the vehicle veer off the right side of the roadway, drive through a small part of the yard over the driveway and through the landscaping pavers, and striking a mailbox post.

Mr. Severance said the vehicle turned left heading south on Society Court. Mr. Severance said he watched the vehicle pull into the address of 7052 Society Court, and he watched the driver exit the vehicle and enter his residence.

Mr. Severance completed a witness statement to the incident. After speaking with Mr. Severance, I stopped at 2823 Fernside Court and spoke with the property owner, Lance Levi. Mr. Levi expressed his concern that he had children playing in the yard, and he would like his mailbox replaced.

I took digital photographs of the yard where unit #1 veered off the roadway, and photographs of the landscape pavers and the mailbox post. I measured the heights of the mailbox post where unit #1 had stuck the post.

I gathered Mr. Levi's information and completed an Exchange of Information Form and told Mr. Levi that I would return after receiving all of Unit #1's information.

At 1520 hours, I located 7052 Society Court and observed the vehicle parked in the driveway, as it was described to me by Mr. Severance. I entered Ohio registration "DMT 7673" into LEADS, and it showed that Steven T. Buchholz was the registered owner and that he resided at that same address. I approached the vehicle and observed damage to the right front bumper, the right front headlight and I noticed an upward shift in the placement of the hood.

A Gold Emerald burning bush leaf and stem were found on Mr. Buchholtz's vehicle. I met with Mr. Buchholz and his wife. I told Mr. Buchholtz that I was investigating an crash and that his vehicle was involved.

Mr. Buchholz said that had been driving the truck and did not remember or acknowledge that he had hit a mailbox.

I took digital photographs of Mr. Buchholtz's vehicle and measurements of the vehicle. I gave Mr. Buchholz the option of completing a witness statement to the incident and he decided to do so.

Mr. Buchholz was given a citation for failure to control and he was given a waiverable court appearance date of Tuesday, October 20, 2015 at 0830 hours at the Vandalia Municipal Court.

I completed the Exchange of Information form and gave Mr. Buchholz his the pink copy and asked if he had any questions, and he told me no. I thanked Mr. Buchholz for his understanding and cooperation, and I left with no further incident.

I returned back to Mr. Levi's address and gave me his yellow copy of the exchange form and asked if he had any questions and he told me no.
