

On Friday, October 30 2015 at 1132 hours, I was dispatched to the Red Roof Inn located at 7370 Miller Lane, Butler Township, Montgomery County, Ohio on the report of a hit and run crash.

Upon arrival, I made contact with the complainant, Ryan H. Britt. Mr. Britt advised that he was told his vehicle, a 2011 Hyundai Sonata, light blue in color, bearing North Carolina registration BDA7830, had been struck by a vehicle around 0854 hours. Mr. Britt advised that the front desk had more information concerning the incident. Mr. Britt showed me where his vehicle had been struck on the left rear portion. I observed a small dent and some red paint transfer. Mr. Britt's vehicle was parked on the southwest portion of the parking lot facing southbound.

I then made contact with the front desk worker, Terri Wells. Ms. Wells advised the subject who had witnessed the crash was Charles Shirk. She advised she did not have a phone number for Mr. Shirk, but would advised him to contact the police upon his return to the hotel.

I was later contacted by Mr. Shirk. Mr. Shirk advised that he observed a white female subject driving a small red vehicle, bearing Ohio registration GOC1518. Mr. Shirk advised that the vehicle backed into Mr. Britt's vehicle, and that the damage would be on the left rear portion of the suspect vehicle.

On October 31, 2015 at 0610 hours, I found the suspect vehicle parked in the parking lot of the Red Roof Inn. I left a business card for the driver to contact me regarding the crash.

I was later dispatched to the Red Roof Inn, and made contact with Sybil J. Toney. Ms. Toney advised she had left a note on Mr. Britt's vehicle after she had hit it, but it must have blown away. Ms. Toney provided me with all of her information for the crash.
