



On Monday November 23, 2015 at 2030 hours, I responded to Town Center Drive and York Commons Boulevard, Butler Township, Montgomery County, Ohio in reference to a vehicle accident.

Upon arrival, I met with Wencel F. Hetman, who stated that he was in his blue Saturn VUE, bearing Ohio registration 077XRY, and he was turning left onto York Commons Boulevard from Town Center Drive, when a green Regional Transit Authority (RTA) bus collided with him in the intersection.

I spoke with the bus driver, Gary Alan Houshel, who stated that he made a complete stop at the stop sign at York Commons Boulevard, and when he began to turn left onto Town Center Drive, Mr. Hetman proceeded into the intersection, striking the RTA bus on the left side.

There were approximately five people on the bus, with no reported injuries. During my investigation, I did not collect the bus passengers names and information for the accident report.

I issued Mr. Hetman a citation for right of way, stop sign (ORC 4511.43) and I gave him a court date of Monday November 30, 2015 at 0830 hours, at Vandalia Municipal Court, if he chose to contest the citation.

Regional Transit Authority supervisor Nathan Anderson arrived on scene, per request of Mr. Houshel.

I received a message from dispatch at 0026 hours on Tuesday November 24, 2015, that Mr. Houshel was being transported to Grandview Medical Center by Dayton Medics. I spoke with Travis, supervisor with RTA, he stated that Mr. Houshel informed them that he was having back pain from the vehicle accident.

Nathan Anderson, supervisor for RTA, provided a courtesy card, indicating two witnesses that were at the bus stop when the accident occurred. RTA courtesy card has been attached to the report.

There was nothing further to report at this time.
