



On Saturday, December 7, 2015 at 0128 hours, I was dispatched to 651 Martindale Road in Butler Township, Montgomery County, Ohio regarding a crashed vehicle. The vehicle was unoccupied and the driver was not on-scene. The fog in this location was thick at the time of the crash.

Upon my arrival, I found a brown 2005 Ford F350 with Ohio license plate PHD4896 sitting in the south bound lane of travel. There was oil and scrape marks on the roadway. The two front tires were flat and there was damage to the left front fender area on the vehicle.

During my investigation, it was found the vehicle was traveling east on Martindale Road and when at 651 Martindale Road, the vehicle drove off the left side of the roadway while attempting to negotiate a curve and struck a traffic sign and a tree. The vehicle then entered back onto the roadway south bound and stopped in the middle of the road. The vehicle then proceeded backwards and stopped in the south bound lane of traffic.

The undercarriage of the vehicle was damaged, which caused the vehicle to rest on the snow plow supports. As the vehicle was proceeding backwards, the snow plow supports caused scrape marks in the asphalt.

I took photographs of the vehicle and crash scene. The vehicle was towed to Busy Bee Towing and a hold was placed on the vehicle until I could make contact with the owner, Kevin D. Roberts.

On Monday, December 7, 2015, I made contact with Mr. Roberts via public service. After speaking with Mr. Roberts, he arrived at the Police Department at 2018 hours. Mr. Roberts explained what happened during the crash and he provided a written statement. Mr. Roberts stated there were no passengers inside the vehicle, and he was not injured.

I explained and issued citation number 40666 to Mr. Roberts for failure to control. At 2150 hours, I contacted Busy Bee Towing and lifted the hold that was on the vehicle.
