





On Thursday, December 24, 2015 at 0257 hours, I was dispatched to the area of Martindale Road and Kley Road in Butler Township, Montgomery County, Ohio, in reference to an auto accident.

At 0310 hours, I arrived on the scene. I located the crashed vehicle about 75 feet west of the driveway for 696 Martindale Road. The vehicle is described as a red, 1998 Ford Mustang, bearing an Ohio license plate of GCZ3302. It returned to a Christian T. Gauvey.

The vehicle was unoccupied, barely off the roadway. The vehicle had ran off the left side of the road and collided with a row of trees. The vehicle had minor front end damage from the trees but was now buried to the frame in the mud and gravel from the roads edge.

I requested dispatch to attempt to contact the owner of the vehicle. At the same time I contacted a Union Police officer and requested he go to the address listed on the registration, 118 S. Old Mill Road in the city of Union, in an attempt to locate Mr. Gauvey.

A Union PD officer advised me the the registered owner of the vehicle was to be at work at the Procter and Gamble warehouse on Airpark Boulevard also in the city of Union. The Union officer was relocating to the Procter and Gamble warehouse to attempt to locate the driver.

I conducted a vehicle inventory prior to the vehicle being towed. Inside the arm rest glove box, I located a loaded Taurus PT1911 .45 ACP (Serial Number NGW84999) with one magazine. The gun was loaded with seven in the magazine and one in the chamber. I took possession of the gun for safekeeping. I ran the serial number through the LEADS Database. It was not reported stolen.

I requested dispatch to send Busy Bee towing for the vehicle. Busy Bee towing arrived on the scene and removed to the vehicle to their secure tow lot.

I relocated to the Procter and Gamble warehouse and met with Christian T. Gauvey, the owner of the vehicle. He explained that at about 0215 he was going for lunch and lost control in the turn. He collided with the trees and then got stuck trying to get out. I told him that I was doing a crash report and that he was going to be cited for failure to control.

I completed citation number 41595 for failure to control. I gave him a court date of December 30, 2015 in the Vandalia Municipal Court. I completed a property Disposition Receipt form and returned the firearm to Mr. Gauvey, and he signed the disposition form.

Mr. Gauvey was released from the Procter and Gamble warehouse.
