



On Wednesday, May 20, 2015 at 1043 hours, Sergeant Morgan and I were dispatched to Peters Pike at the Interstate 70 overpass in Butler Township, Montgomery County, Ohio on the report of a roll over crash.

Upon arrival, Sergeant Morgan was advised by Officer Erbaugh from Vandalia Police Department that the vehicle involved in the crash, had been involved in a crash at Stonequarry Road and Peters Pike in Butler Township, Montgomery County, Ohio.

I then responded to the intersection of Stonequarry Road and Peters Pike, and I made contact with Sharon S. Yoakum. Ms. Yoakum advised that her vehicle had been struck by a brown car traveling westbound in the eastbound lane on Stonequarry Road. Ms. Yoakum advised the vehicle had left the scene immediately after the crash.

During my investigation of the crash, I was contacted by a Lloyd Brenner (P/S 937-470-1494) who advised he had seen the brown vehicle driving down the street in the wrong direction.

I was advised by Sergeant Morgan that operator of the vehicle that had left the scene was Calena R. Cook, and that she may have suffered a medical issue causing the crash to take place.

On May 25, 2015 I was able to make contact with Diana Kiser by phone. Ms. Kiser is the daughter of Ms. Cook. She informed me that Ms. Cook had suffered a massive stroke at the time of the accident, and was still in the hospital.

I also made contact with Suzanne Harmon, who had called in for a welfare check on Ms. Cook the day of the accident. Ms. Harmon told me that she was speaking to Ms. Cook who was driving in her car on her way to visit her. Ms. Harmon advised that she all of a sudden heard Ms. Cook start slurring her words as if something had gone wrong. Ms. Harmon advised she heard a crash on the other end of the phone, and had no further contact with Ms. Cook during this time.
