On Sunday, May 24, 2015 at 1139 hours, I was dispatched to the Drury Inn located at 6616 Miller Lane in Butler Township, Montgomery County, Ohio in reference to a private property hit and run accident.

Upon arrival I spoke with Unit#2 (Melvin D. Syril III) who advised that his red 2007 Lexus bearing a Georgia registration of DV976Y was struck sometime over night while he was in his motel room between the hours 2100 til 1100 hours.

Unit#2 was legally parked in a marked parking space in the parking lot located on the west side of the motel. It is unknown if Unit#1 struck Unit#2 while pulling in or out of the parking space located directly to the south of where Unit#2 was parked, causing damage to the right rear of Unit#2. The occupant of Unit#1 after striking Unit#2, left the scene without making any attempt to report the crash.
