





On Thursday, May 28, 2015 at 1321 hours, I was dispatched to Walmart, located at 3465 York Commons Boulevard, Butler Township, Montgomery County, Ohio in reference to a hit and run private property crash.

Upon my arrival at 1325 hours, I came in contact with the caller, Cindy Biggs. Ms. Biggs stated her white Ford Fusion, bearing Ohio registration, ERU5944, had been struck while in the parking lot of the Walmart. Ms. Biggs stated she went inside the store between 1220 and 1240 hours and when she came out of the store she found her fog light cover sitting on her hood. Ms. Biggs stated she located the damage and believed that it had just occurred. I observed damage to the left front of Ms. Biggs car. There was red and yellow paint transfer near the fog light, along with black marks. I took digital photographs of the damage to the vehicle.

I reviewed Walmart video footage and was able to locate Ms. Biggs car entering the parking lot and parking in row 9. During the time that Ms. Biggs was inside of the store there did not appear to be a vehicle that struck Ms. Biggs car, or anyone near the vehicle that may have placed the fog light cover on her vehicle.
