
NARRATIVE

Unit #1 was traveling west on Little York Road and when at the intersection of little York Road and Meeker Road, Unit #1 attempted to negotiate a left turn south bound onto Meeker Road, and lost control of his vehicle. Unit #1 left the roadway right into the yard of 9019 Meeker Road, struck the mailbox and the cement wall at this address. The vehicle then spun its tail end outward, slid sideways and ended up in the tree line at 9019 Meeker Road facing north bound.

The operator was cited for failure to control and charged with OVI. Passenger complained of a head trauma but refused further medical treatment from Butler Township Medics.

Exchange of information was given to owner of 9019 Meeker Road and 403 Aullwood Road, where the top portion of the mailbox landed. Owner at 403 Aullwood stated that there was no damage that he cared to report.

No insurance information was given by Unit#1.


