



On Friday, July 17, 2015, at 1555 hours, I was dispatched to the intersection of North Dixie Drive at Benchwood Road for an injury crash.

Upon my arrival at 1601 hours, I parked my marked Butler Township Police vehicle at the intersection on the east side of westbound Benchwood Road in the right lane. A Montgomery County Sheriff Unit, A Vandalia Police Department Unit, Butler Township Fire Unit, and a Vandalia Medic unit were already on scene. I observed a white Mercury Sable bearing Ohio registration FNT9691 parked in the right lane of eastbound Benchwood Road. I observed damage to the Mercury's front end consistent with a frontal collision. The area surrounding the left head lamp appeared to have been the point of impact. I observed a black Pontiac Grand Am bearing Ohio registration parked on the northeastern corner of the intersection in the right lane on northbound North Dixie Drive. The Pontiac was parked at an angle of approximately 45 degrees with the front of the vehicle pointing towards to corner of the intersection. I observed damage to the Pontiac's front end consistent with a frontal collision. The area immediately behind the right head lamp appeared to have been the point of impact.

A Vandalia Officer pointed to a white male standing at the northeastern corner of the intersection and advised that he was the driver of the Pontiac, that he had been driving southbound on North Dixie Drive, attempted a left turn, failed to yield, and collided with the driver of the Mercury. The Vandalia Officer pointed at a black male sitting at the southeastern corner of the intersection and stated that he was the driver of the Mercury, that he had been traveling northbound on North Dixie Drive when he was struck by the Pontiac. The Vandalia Officer handed me a Vandalia Division of Police Voluntary Statement, which was completed by a Quinton Hamilton stating that the traffic signal was yellow, the Pontiac attempted a left turn, and the white Mercury traveled straight.

I went to the white male, identified as Jacob L. Oehlenschlager / dob 01/29/1997, and obtained his Ohio Driver License. I asked if he had sustained any injuries and he replied that he had not. I also obtained his insurance information and told him to remain where he was. I went to the black male, identified as Andre E. Laken / dob 03/17/1992, and asked for his Ohio Driver License. Laken stated that he did not have his license, but provided his social security number. I asked for his insurance information and he replied that it was in the vehicle. I asked Laken if he were injured and he replied that his neck was hurting. I instructed him to remain seated. The Vandalia Medics approached and started to evaluate him.

I went back to my police vehicle, got out the camera, and took eight digital photographs of the crash scene and vehicles. As I concluded taking the photographs, the Vandalia Medics loaded Laken into a medic unit and transported him to Grandview Hospital. The Sheriff Deputy asked how he could assist and I requested that he call Busy Bee for two tows. He did so. The westbound traffic on Benchwood Road began to attempt to enter the scene around our parked police vehicles. I requested the Vandalia Unit to reposition to Town Center Drive and redirect the westbound traffic north. He did so.

The Butler Fire personnel completed their duties and departed the scene. Busy Bee towing arrived and began to hook up both vehicles for towing. Sergeant W. Karolyi arrived and asked how he could assist. I requested that he enter the Mercury and obtain the insurance information. He did so and provided it to me. Busy Bee towed both vehicles away from the scene. I completed a Butler Township Police Department Exchange of Information sheet.

I approached Oehlenschlager and gave him a Traffic Crash Witness Statement to complete. He did so. In his statement, Oehlenschlager states that he was at the intersection of North Dixie Drive and Benchwood Road as the traffic signal turned yellow. He stated that he attempted to turn left when he noticed "a vehicle rushing into the intersection" where he was hit.
