



On Thursday, July 23, 2015 at 1005 hours, I was dispatched to 3489 Little York Road located in Butler Township, Montgomery County, Ohio for a non-injury crash.

Upon my arrival at 1007 hours, I observed a white GMC Sierra pick-up truck and a white Cadillac STS parked in the roadway in the eastbound lane. Both vehicles were west of the driveway to the Christian Life Center Church located at that address and facing east. I activated my emergency lights and exited the vehicle. I asked both drivers if anyone was injured and both replied that no one was injured. I took nine digital photographs of the vehicles and the scene. I then had both vehicles pull into the driveway of 3489 Little York Road to clear the roadway.

The white GMC Sierra pick-up bore Ohio registration GGJ2470 and was driven by the registered owner, Antoine L. Blackman, who I identified via his Ohio Driver License. The white Cadillac STS bore Ohio registration ENJ9773 and belonged to Chris E. Gebhart, but was driven by Connie L. Gebhart, who I identified via her Ohio Driver License. In the right rear seat of the Cadillac was a minor passenger who lives with his grandmother Connie.

I obtained Traffic Crash Witness Statements from Blackman and Gebhart. Both parties state that they were traveling eastbound on Little York Road when a car suddenly stopped to make a left-hand turn to turn into the Christian Life Center Church. Gebhart was able to stop in time to avoid hitting the turning car. Blackman attempted to stop, but did not and struck Gebhart.
