



On Saturday, July 25, 2015 at 0013 hours, I was dispatched to 700 Old Springfield Road in Butler Township, Montgomery County, Ohio for a single vehicle crash where a vehicle had struck a tree. According to the caller, they did not see anyone get out of the vehicle.

I made an emergency response to the scene due to the unknown nature of any injuries. On arrival, I located a tan 1997 Mazda 626 bearing Ohio registration GIG 6223 crashed into a tree in front of 11302 Kley Road. The vehicle was unoccupied.

I checked the area around the crash scene, but did not locate anyone. I ran the registration and the vehicle returned to a Farrah C. Mason out of West Milton. I requested dispatch to see if there was a contact number for Mason. Dispatch advised that West Milton had a phone number, but it went straight to voice mail.

A Union PD officer advised that he had located a white male on Old Springfield Road west of the crash scene at the entrance to the Five Rivers Metropark. I requested Officer Brown to respond to this location. (Please refer to Officer Brown's narrative.)

I requested dispatch to have West Milton PD go to Mason address at 1169 Sanlor Avenue Apartment G. Dispatch later advised that West Milton had contacted the resident there and they advised that Mason no longer was living there.

I took digital photographs of the vehicle and its damage. Inside the vehicle, were an unopened 12 ounce can of Budweiser brand beer and an opened 12 ounce can of Budweiser brand beer in a blue can holder lying on the floorboard of the driver's seat. I collected the two cans of beer as evidence to identify the driver.

Officer Brown said he contacted Jeffrey D. Nickels, who had denied being the driver or a passenger in the crashed vehicle. He also denied knowing the registered owner as well. According to Officer Brown, Nickels was intoxicated and did not have a valid driver's license, but did hold an Ohio Temporary Driver's permit.

The vehicle was inventoried and towed by Busy Bee Towing to their facility until the owner could be contacted.

I returned to the police department and poured the small amount of beer that was left in the opened beer can into a evidence vial. I marked both cans and the vial, packaged them, tagged them, and placed the evidence into locker #104. It will be sent to the Miami Valley Regional Crime Laboratory for DNA and fingerprint analysis.

On Saturday, July 25, 2015 at approximately 1745 hours, I was advised by Sergeant Bilbrey that Farrah Mason had called and said that her vehicle had been stolen from 1313 Main Street Apt. B in Troy, Ohio sometime overnight after 2300 hours. Ms. Mason had reported the matter to Troy PD. Sergeant Bilbrey also advised that Nickels was Mason's next door neighbor in Troy.

I contacted Mason by phone and she reiterated that the vehicle was stolen overnight. Mason said she only knows that Nickels lived next door to her, but that she does not know him that well. Mason denied allowing Nickels permission to use her vehicle or allow him to use it in the past. She also denied being the driver in the vehicle or knew who crashed her vehicle.

I advised Mason that her vehicle was at Busy Bee Towing and that the Troy PD wanted to do evidence collection on it. Mason advised she understood.

After speaking to Mason, I contacted Busy Bee Towing and released the hold on it. I advised Busy Bee Towing that Troy PD would be contacting them about towing the vehicle for evidence processing.

At this time, it is unknown who was driving the vehicle when it was crashed.

There was nothing further to report at this time.

On Saturday, July 25, 2015 at 0020 hours, I was dispatched near the intersection of Kley Road and Old Springfield Road located in Butler Township, Montgomery County, Ohio for an injury crash.

Upon my arrival at 0032 hours, I saw a tan 1997 Mazda 626 had crashed into a tree. Sergeant M. Morgan had me drive south in an attempt to located the driver of the crashed vehicle. I departed in search of that driver. At 0045 hours, Morgan told me that an Union officer had detained a white male at Old Springfield near the entrance of the park and instructed me to ascertain whether he could be involved in our crash.

I made contact with the Union officer and the detainee, Jeffrey D. Nickels / dob 06/08/1982, who I identified via his Ohio Driver License. Nickels stated that he "had been dropped off about a mile up the road" by a white female he knew as Megan. Nickels stated that he and Megan had spent the last two days together "kicking it". Megan told Nickels that she was married, he decided to terminate the relationship, and she kicked him out of the car. Nickels described Megan as a white female with black hair, hazel eyes, weighing 150 pounds with "hellbound" tattooed on her neck. Nickels explanation and the proximity to the accident scene made both the Union officer and I suspicious. Nickels swayed as he stood talking to the Union officer and myself and he slurred his words. I illuminated Nickels with my flashlight and did not observe any injuries or other indications that he had been involved in the crash.

I felt that I did not have any cause to further detain Nickels and released him. The Union officer gave Nickels a courtesy ride away from the area. I resumed my search for the driver and drove into the park. I did not find the driver and returned to Morgan before clearing the call and resuming patrol.
