



On Tuesday, July 28, 2015 at 1751 hours, I was dispatched to the intersection of US 40 and Frederick Pike in Butler Township, Montgomery County, Ohio on a two vehicle crash. According to the dispatch, both vehicles had pulled over into the lot of the Polk Grove Church located at 9190 Frederick Pike.

On arrival, I saw only one vehicle, which was a silver 2003 Ford Ranger bearing Indiana registration TK313MHH. I contacted Jeremy A. and Marcia J. Shaver. Mr. Shaver advised he was driving the truck and was stopped in the westbound lane of US 40 approximately 100 feet east of the intersection with Frederick Pike. Mr. Shaver said he was hit in the rear by a white Cadillac bearing Ohio registration GJM6730.

Mr. Shaver said he and the other driver pulled into the parking lot of Polk Grove church. Mr. Shaver said the other driver identified himself as Carnell Sims, Jr. and showed them his insurance card. Mr. Shaver said that Mr. Sims did not want to involve police and requested that they just exchange information because Mr. Sims had a Commercial Driver's License. When Mr. Shaver said he and his wife insisted that the police be involved, Mr. Sims left the scene because he did not want to wait for an hour.

Mr. Shaver took a photograph of Mr. Sims front license plate along with the damage to Mr. Sims front bumper area. Mr. Shaver said Mr. Sims wrote his name, address, phone, and a short signed statement acknowledging blame for the crash. I took the paper note that Mr. Sims wrote as evidence.

Mr. and Mrs. Shaver said that they had possible injuries, but declined to have a medic respond. Both also completed written statements concerning the crash. Both positively identified Mr. Sims from his LEADS photograph.

At approximately 1830 hours, I attempted to contact Mr. Sims at the phone number (937-260-0574) he gave Mr. and Mrs. Shaver. Upon calling the number, it went straight to voicemail. I left a message for Mr. Sims and requested he contact me in reference to the crash.

As of Friday, July 31, 2015, I have been unable to contact Mr. Simms. The citation will be forwarded to the Vandalia Municipal Court for service.

There was nothing further to report at this time.
