



On Monday, July 27, 2015 at 1546 hours, I was dispatched to 6990 Peters Pike located in Butler Township, Montgomery County, Ohio for a non-injury crash.

Upon my arrival at 1553 hours, I saw a blue Honda Accord and a red Ford Thunderbird parked in the driveway. The Honda had damage to the right rear corner of the vehicle while the Ford had damage to the front left corner of the vehicle. The occupants of both vehicles were standing between both vehicles exchanging information. I looked inside both of the vehicles and neither of the vehicle's airbags deployed. I asked all parties involved if they were injured and all replied that they were not.

I retrieved the Ohio Driver Licenses of both drivers as well as their proof of insurance and I obtained the social security number of the one passenger. I identified the driver of the Ford as Ryan Nicholas Grant / dob 11/18/1996 via his Ohio Driver License. Grant was the sole occupant of the Ford. I identified the driver of the Honda as Audra L. Sparks / dob 10/27/1971 via her Ohio Driver License and I identified David B. Sparks / dob 01/12/1968 via his social security number. David was seated in the front right seat of the Honda.

I took nine digital photographs of the vehicles and crash scene. I completed an exchange of information form and gave each driver their copy. I obtained Traffic Crash Witness Statements from all parties. All parties stated that they were driving northbound on Peters Pike in the northbound lane when the traffic ahead of them suddenly stopped to make a left turn (west) onto Meeker Road. Sparks was able to come to a complete stop, however Grant was unable to stop in time and collided with the rear of Sparks. Grant did swerve to the right with his right tire leaving the roadway causing a skid in the grass to the east of the roadway. After the collision, all parties pulled into the driveway at 6990 and called the police.

I released Audra and David and they departed. I issued Grant citation 41640 for assured clear distance ahead. I advised Grant of his court date of August 3, 2015 at 0830 hours. I advised Grant that if he failed to show up for court, he could face additional criminal penalties. I released Grant and he departed.
