



On Friday, August 28, 2015 at 0703 hours, I was dispatched to the intersection of Frederick Pike and North Montgomery County Line Road for a single vehicle crash. The complainant stated that a maroon semi-trailer with a flatbed trailer had knocked over the signs at the intersection.

Upon my arrival at 0721 hours, I observed the street signs, a Butler Township Sign, some Montgomery County Signs, and mailboxes laying on the ground on the southeast corner of the intersection. I took eight digital photographs of the damage.

I left the intersection of Frederick Pike and North Montgomery County Line Road and traveled eastbound on North Montgomery County Line Road to see if the vehicle had done any additional damage. I arrived at Dog Leg Road, turned south, drove, and then turned west onto Old Springfield Road to a location near the intersection of Union Airpark Boulevard. There at the intersection of Old Springfield and Union Airpark Boulevard where three yellow in color semi-trailers with flatbed trailers unloading concrete piping. I examined the sides of the tractors and trailers for any evidence of striking the signs, but did not see any on those three vehicles.

I left those vehicles and traveled to the Flying J Truckstop located at 175 Northwoods Boulevard in Vandalia, Ohio. Upon my arrival, I drove around the stop looking for any maroon tractors with a flatbed trailer. I located one tractor with a flatbed and inspected the sides for any damage consistent with striking the signs. I did not see any damage to the tractor or the flatbed trailer. I have no leads or suspects at this time.
