



Upon my arrival, I observed a grey Toyota Camry that was crashed into a tree. The vehicle hit the tree on the front right side of the vehicle. The driver was still inside of the vehicle.

I made contact with the driver. The driver didn't appear to have any major lacerations. I asked him what his name was and he stated it was Shane Hammond. I asked Mr. Hammond where he was injured and he stated that his chest hurt and it was difficult to breath. I advised Mr. Hammond to stay in the vehicle until the medics arrived so he didn't further injure himself.

I asked Mr. Hammond what happened and he advised that he had work done on his vehicle on Friday. Mr. Hammond stated that he had new axles put on the vehicle. Mr. Hammond stated that he was traveling southbound on Frederick Pike, when the wheels pulled right and he went off of the roadway and hit a tree.

While speaking with Mr. Hammond, I observed the chest strap was secured around him. Mr. Hammond did not have the waist strap secured around him. The vehicle's steering wheel was collapsed in and the dash was collapsed in from Mr. Hammond being thrown into the steering wheel and dash.

There were some people around that found the vehicle, but no one witnessed the crash.

Due to his size, the medics had to use mechanical tools to cut the door off of the vehicle to get Mr. Hammond out of the vehicle.

I took pictures of the scene for evidence.

Mr. Hammond was transported to Miami Valley Hospital.

Mr. Hammond's vehicle was towed by Busy Bee.

I traveled to Miami Valley Hospital to check on Mr. Hammond's status. Mr. Hammond was in the trauma center and I was unable to communicate with him. I issued a citation Mr. Hammond for failure to control. I left the citation with Mr. Hammond's property.
