



On Sunday, January 31, 2016 at 0818 hours, I was patrolling Benchwood Road and when at Commerce Center Boulevard in Butler Township, Montgomery County, Ohio, I observed that a light fixture and glass laying in the northbound lane of Commerce Center Drive. I called dispatch and advised them I had a personal property hit skip crash and pulled onto Commerce Center Boulevard.

I observed the eastern lamp post was slightly bent and the fixture normally attached to the top was laying on the ground. I picked up the pieces from the roadway and placed them onto the ground near the lamp post. I observed drag marks on the ground and followed them to an empty parked green Dodge Ram pickup with damage to its right front, which was parked in the Speedway parking lot located at 6501 Miller Lane. The Ohio registration on the vehicle was GIX6128. I ran the registration through the LEADS database to learn that the registered owner was Nicholas L. Hillyard and I asked dispatch to see if they had any contact information for Hillyard. They did not. I opened the unlocked doors of the truck to determine if I could find anything to indicate the phone number or location of the driver as well as to determine if anyone had been injured in the crash. I did not see any blood or any obvious signs of trauma. In the truck were several cellular telephones and a brown purse. I opened the brown purse and located an Ohio Driver License for Jamie L. Dolan. While I was looking in Dolan's purse, her cellular telephone rang. I answered it and identified myself as a police officer and asked for the identity of the caller. The male caller identified himself as Hillyard. I asked for his location and he informed me that he was in room 230 of the Comfort Inn located at 7125 Miller Lane. I asked when he last saw his truck and he replied that he had left it at the Wings Sports Bar and Grille located at 7902 North Dixie Drive after having drank too much. I informed him that I had found his truck at Speedway and it had been crashed. He asked if I knew the whereabouts of his fiancée, Dolan, and I replied that I did not. I informed Hillyard that I would pick him up and take him to the truck.

I drove to the Comfort Inn and picked up Hillyard. We drove back to the Speedway where he retrieved personal property from the truck. The keys were not in the truck. Hillyard spoke with a representative of Speedway and made arrangements to have the truck removed. I asked Hillyard to tell me what had happened. Hillyard stated that on Sunday, January 31, 2016 between 0030 and 0100 hours, he and Dolan were asked to leave the Wings Sports Bar and Grille. They had been there with two of their friends, Eric C. Constantine and Sandra S. Ball. I ran all four individuals, Hillyard, Dolan, Ball, and Constantine through dispatch and all were current and clear. Hillyard and Dolan left in a cab, which took them to the Comfort Inn. Hillyard related that he and Dolan exchanged words and she refused to exit the cab. Hillyard stated that he and the cab driver were able to persuade Dolan to exit the cab and the cab departed. Hillyard and Dolan continued to exchange words and Hillyard left Dolan sitting on the stairwell in the Comfort Inn while he went to their room, 230. He stated that when he awoke, Dolan was not there and he was concerned about her safety.

Hillyard and I returned to the Comfort Inn and made contact with Constantine and Ball. I asked for and received permission to enter their room and immediately asked where the keys to the Dodge were. Constantine replied that he had the keys and pointed to a set of keys on the night stand. I retrieved the keys, showed them to Hillyard and he confirmed that they were his keys. I asked Constantine and Ball who was driving and Constantine replied that he was driving. I asked what had happened and he replied that he and Ball departed the Wings Sports Bar and Grille between 0030 and 0100 hours and were traveling back to the Comfort Inn via Benchwood Road. When he attempted a left-turn onto Commerce Center Boulevard he lost control and struck a light post. He was able to drive the truck into the Speedway parking lot and park the truck into a parking space. I issued Constantine citation 42153 for failing to maintain reasonable control of a vehicle in violation of 4511.202 of the Ohio Revised Code.

I asked Constantine and Ball if they knew the whereabouts of Dolan and they replied that they did not. I instructed Hillyard to call Dolan's friends to see if any had heard from her while I checked all of the hotels along Miller Lane. While I was checking the hotels, Hillyard contacted me and informed me that he had found Dolan. I returned to the Comfort Inn and spoke with Dolan and confirmed that she was safe and well.
