





On Monday, October 24, 2016, at 1035 hours, I was dispatched to the intersection of Miller Lane and York Commons Boulevard located in Butler Township, Montgomery County, Ohio, for a property damage crash.

Upon my arrival at 1038 hours I observed a blue Chrysler Town and Country mini van bearing Ohio registration EOE3786 parked in the east bound lane of York Commons Boulevard with its front left tire laying behind the vehicle. On side of westbound York Commons Boulevard was parked a silver Dodge Journey bearing Ohio registration GCW5835 with a crack in the front bumper on the left side of the vehicle.

After speaking to the occupants of both vehicles and ensuring that no injuries had occurred I received the their report. Unit #1 was driven by Annie P. Frazier and I identified her via her Ohio Driver License. Frazier's passenger, Charles E. McCoy, was sitting in the front right seat and I identified him via his Ohio Driver License. Unit #2 was driven by Heather A. Proffitt and I identified her via her Ohio Driver License. Unit #1/Frazier was traveling southbound on Miller lane and turned right (west) onto York Commons Boulevard. Unit #2/Proffitt was traveling eastbound on York Commons Boulevard in the eastbound lane.
