





On November 3, 2016 at 1252 hours, I was dispatched to 3282 Benchwood Road in Butler Township, Montgomery County, Ohio in reference to a hit and run crash.

Upon arrival, I spoke with Sherry Jones, who was the owner and operator of the vehicle that was stuck. There was visible damage on the driver side of a black 2013 Hyundai Elantra bearing Ohio registration GYR1373 that could be seen.

The damage was consistent with Ms. Jones' story of driving in the center turn lane and being struck on the driver side of the vehicle while attempting to make a left turn into the driveway of 3282 Benchwood Road. After striking Ms. Jones' vehicle, the driver of the second vehicle left the scene without attempting to exchange information. The vehicle last seen driving south on North Dixie Drive.

It is unclear as to why the second vehicle was driving westbound Benchwood Road and then drove left crossing through a turn lane before entering the eastbound lane of traffic and eventually striking Ms. Jones' that was making a left turn.

Ms. Jones and her son Johnny Jones described the hit and run vehicle as a white Honda Civic. The driver of the hit and run vehicle was described as a black female and had a black male with dread locks in the passenger seat.

A caller that was not on scene contacted dispatch with an Ohio registration GQU3866 for the suspect vehicle. I spoke with caller, Mr. Tom Cope, by telephone, and he described the vehicle as a white Oldsmobile Alero.

I ran the registration which was expired, and it came back to a chrome color Oldsmobile. I attempted to make contact with the registered owner at 3517 E. Second Street in Dayton, but I was told by the owner of that residence that the subject hasn't lived there for over a year.

It was not known if the registration that Mr. Cope gave was correct or if the registration was being used on another vehicle. I checked for any other additional vehicles owned under that name that might fit the hit and run vehicle, and I did not find a match.

There was nothing further to report at this time.
