



On Sunday November 6, 2016 at 1546 hours, I responded to 2610 Little York Road, in Butler Township, Montgomery County, Ohio in reference to a hit and run crash.

Upon arrival, I met with Joseph Yahle, who stated that an unknown vehicle ran off the roadway and struck two mailboxes and a road sign. Mr. Yahle advised that he heard a loud noise, and when he looked outside, he saw a dark grey sedan leaving the area of the crash. The vehicle proceeded west on Little York Road. Mr. Yahle was not able to get an accurate description of the vehicle.

A few minutes later, I received notification from dispatch that Montgomery County Regional Dispatch contacted them with the possible license plate number for the suspect vehicle. Montgomery County Regional Dispatch advised that a dark grey vehicle was weaving all over Little York Road and possibly turned north onto Frederick Pike.

The license provided was Ohio FWG2761, which was registered to Amanda K. Todd from Centerville, Ohio. I contacted the Centerville Police Department and requested an officer make contact with Ms. Todd and have her contact me in regards to the vehicle crash. I was informed by dispatch that a Centerville officer left a business card to contact the Huber Heights Communications Center.

At 1755 hours, I received a message from dispatch to contact Adam Todd in regards to Amanda Todd. I contacted Mr. Todd, and he advised me that his niece, Amanda Todd, admitted to him that she struck several mailboxes earlier in the day while she was on Little York Road. Mr. Todd stated that Amanda was currently on probation for a drug offense. I explained to Mr. Todd that I needed to speak with Amanda in regards to the crash.

I also made three more attempts to contact Amanda in regards to the hit and run crash, and I left several phone messages for her to contact me. I attempted contact with Amanda twice on Monday November 7, 2016 and once on Tuesday November 8, 2016.

I received a phone call from Amanda Todd on Wednesday November 9, 2016. Ms. Todd explained to me that she ran off the roadway because she was texting on her cell phone. Ms. Todd stated that she left the scene of the crash because she was scared. I explained to Ms. Todd that she had 24 hours to report a crash in the state of Ohio. Ms. Todd advised that she was not aware of that.

I issued Ms. Todd a citation for failure to maintain reasonable control. I advised Ms. Todd of her court date of November 16, 2016 at 0830 hours at the Vandalia Municipal Court if she chose to contest the citation. I gave Ms. Todd a copy of the citation.

The damaged property included two mailboxes and a road sign. The first mailbox belonged to property owner Devin Justice, 2630 Little York Road, in Dayton, Ohio 45414, and with a phone number of 937-516-2066. The second mailbox owner was Dan Yahle, 2610 Little York Road, in Dayton, Ohio 45414, and with a phone number of 937-890-1296. The traffic sign belonged to Butler Township, 3710 National Road, in Dayton, Ohio 45414, and with a phone number of 937-890-1218.

There was nothing further to report at this time.
