





On Monday, February 1, 2016, at 1342 hours, I was dispatched to the Walmart located at 3465 York Commons Boulevard in Butler Township, Montgomery County, Ohio, for a private property crash hit and skip.

Upon my arrival, I made contact with the owner of unit #2, a black Buick Enclave bearing Ohio registration GSJ3695, who I identified as Elizabeth A. Ater via the LEADS database, who gave me her report. Ater stated that she, her husband, and child entered Walmart at 1145 hours to shop. They parked near the center of row 11 with the nose of the vehicle facing south. They exited the store and returned to their vehicle at 1300 hours and discovered a scratch on the right rear door handle. The scratch was horizontal across the center of the horizontal handle and was approximately four inches in length and one eighth of an inch in height. There was no other damage to the vehicle. At first, I suspected that the scratch was caused by a shopping cart. I retrieved a nearby shopping car and placed it next to unit #2. The highest point of the shopping cart was several inches below the scratch on unit #2.

I went to the asset protection office and made contact with Asset Protection Manager John Schultz. We reviewed the security camera footage and discovered that at 1213 hours, a black Chevrolet Equinox pulled through the adjacent parking space and into an the parking space northeast of Ater's vehicle driving from south to north. Due to the angle and distance, I cannot affirmatively determine that unit #1 struck Ater's vehicle, however, the height of the side view mirror on unit #1 conforms to the height of the door handle on unit #2. I could not see the vehicle registration on the video footage. Several minutes later, unit #2 left the parking space and departed the parking lot heading east towards Miller Lane. No other vehicles, persons, or objects went near unit #2 from the time they arrived and entered Walmart to the time they returned to their vehicle.
