On Thursday, February 04, 2016 at 1805 hours, I was dispatched to Speedway located at 6501 Miller Lane, Butler Township, Montgomery County, Ohio for a hit skip. Dispatch advised the victim was able to get the license plate of the suspect vehicle.

Upon my arrival, I made contact with the owner of the vehicle that was struck, Gabrielle Whisler. Ms. Whisler advised that she was parked at gas pump 11 facing north, when a dark colored Pontiac Grand Prix was traveling west and attempted to turn north between the other gas pump and her vehicle when the vehicle struck the right rear of her vehicle. Ms. Whisler stated that the driver then backed up and exited the parking lot and traveled east on Benchwood Road.

Ms. Whisler described the driver as a white female.

The manager of Speedway, Kyle Maurer, stated that he observed the crash occur. Mr. Maurer stated that he had video of the incident. Mr. Maurer stated that he also had video of the female inside of Speedway.

I observed the video of the female inside of the gas station. I photographed still shots of the video to help identify the female.

Upon returning to my patrol vehicle, dispatch had messaged me and stated that Huber Heights Police had pulled over the suspect vehicle in October 2015. A female named Amanda Leonard was the driver when the vehicle was stopped. Dispatch sent Ms. Leonard's information to me in the LEADs database. Upon reviewing her driver license photo, I concluded that she was the same suspect I observed inside of Speedway on the video footage.

On Monday, February 08, 2016 at 1900 hours, I attempted to contact Ms. Leonard by telephone using the phone number she gave the Huber Heights Police in October 2015. The phone number was disconnected and I was unable to contact her.

At 2000 hours, I traveled to Ms. Leonard's residence at 1421 Beverly Avenue, Springfield, Ohio to attempt to make contact with Ms. Leonard. I knocked several times on her front door and windows and I was unsuccessful in making contact.

As this time, Ms. Leonard has not attempted to report the crash.
