





On Sunday, March 6, 2016, at 1241 hours, I was dispatched to 6925 Frederick Pike located in Butler Township, Montgomery County, Ohio, for a hit and skip property damage crash.

Upon my arrival at 1243 hours, I observed four sections of wooden fence in the front yard that had been damaged. As I looked closer, I saw tire tracks that lead from the southbound lane of Frederick Pike, which traveled north away from the road to the left and into the fencing. I took ten digital photographs of the scene.

As I was taking the photographs, I made contact with the property owner, Robert L. DeShayes, who I identified via his name and address, who gave me his report. DeShayes stated that he last saw the fencing intact on Saturday, March 5, 2016 at 1700 hours when he left his home to attend worship services. DeShayes continued that his daughter telephoned him on Sunday, March 6, 2016 at 1220 hours and told him that she saw that the fencing had been damaged as she drove by. DeShayes stated that he did not hear or see anything all night. DeShayes also stated that the cost of the damaged fencing was approximately \$400.00.

From the tracks and damage it appears that an unknown vehicle, unit #1, was traveling northbound on Frederick Pike in the northbound lane and when prior to 6225, unit #1 left the northbound lane, entered and left the southbound lane and exited the paved surface of the roadway to the west. Unit #1 then struck approximately four sections of wooden fencing before reentering the paved roadway and continuing northbound on Frederick Pike without stopping to report the crash.
