



On Wednesday, March 9, 2016 at 1759 hours, I was met at the Butler Township Police Department by a subject who wanted to report a crash that occurred around 1710 hours at North Dixie Drive and Little York Road.

The complainant, Russell W. Smith, advised that he had been involved in a crash around an hour prior to making contact with me. Mr. Smith advised he was traveling southbound on North Dixie Drive in the left southbound lane, and that the other vehicle involved in the crash made a right turn from Little York Road to travel southbound on North Dixie Drive. Mr. Smith advised that he had a green light, and that the turn was made wide, and the two vehicles collided.

Mr. Smith advised that he and the other party involved pulled into the day care center on North Dixie Drive. He advised that he and the other operator, whom he described as being a white female with curly hair, and appeared to be in her early 20s or late teens, viewed the damage. Mr. Smith advised that they both indicated that they were not injured from the crash. Mr. Smith advised that an employee of the business told both subjects to move. Mr. Smith advised they both left, but that they did not meet to exchange information. Mr. Smith advised that the vehicle driven by the other subject was a Ford Taurus, blue in color, bearing Ohio registration GFD3072.

Upon running the registration through LEADS, I found that the vehicle came back to a Susan Spangler at 772 Aspen Drive in Tipp City, Ohio. Mr. Smith completed a statement regarding the crash, and I took photographs of his vehicle, a 1994 Ford Ranger, grey in color, bearing Ohio registration FND7515. The damage to Mr. Smith's vehicle was on the front passenger side. Mr. Smith advised the damage to the other vehicle would be near the rear driver side wheel well.

At around 2015 hours, I had dispatch contact Miami County Dispatch to see if a Tipp City Police Department could respond to the residence to look for the vehicle. I was contacted by Officer Dickerson who advised that she observed the vehicle at the residence. Officer Dickerson advised she observed damage to the vehicle. Officer Dickerson made contact at the residence and instructed them to contact me regarding the crash.

I was later contacted by the driver, Laurel Spangler's father, regarding the crash. Mr. Spangler advised that his daughter had been involved in the crash. He advised that after stopping, she was not completely sure if she needed to report the matter any further. Mr. Spangler advised that Ms. Spangler would bring the vehicle to the police department on March 11, 2016 at 1800 hours.

On Friday, March 11, 2016 at 1800 hours, I was met at the police department by Ms. Spangler and Susan Spangler. Ms. Spangler informed me that after stopping for the crash she did not know what to do so she went home.

I asked Ms. Spangler about the crash and she advised that she was making a right turn on a red light from Little York Road to travel southbound on North Dixie Drive. Ms. Spangler informed me that she was not sure how the manner of the collision had occurred. I asked Ms. Spangler if she wished to complete a witness statement, and she advised she did not want to at this time.

I issued Ms. Spangler a citation for turns at intersections. I observed minor damage in the area of her rear driver side wheel well. I photographed the damage.
