





On Saturday, April 2, 2016, at 1146 hours, I was dispatched to 7309 McSmith Lane located in Butler Township, Montgomery County, Ohio, for a hit skip property damage crash.

Upon my arrival at 1149 hours, I met with the complainant, Beverly A. Kaser, who I identified via her Ohio Driver License, who gave me her report. Kaser reported that she heard a crash in her front yard between 1015 and 1030 hours. When went to investigate, she discovered that her mailbox had been knocked over. Kaser stated that several neighbors described the vehicle as a faded red late model Chevrolet Blazer. Kaser further stated that Mr. Gel, who lives at 3600 English Court, had witnessed the crash. I spoke to Gel and while he gave a color, make, and model, he could not provide any registration or description of the driver. I spoke to another neighbor located at 7303 McSmith Lane and she said her husband described it as a red Jeep. All neighbors stated that the vehicle was circling the cul-de-sac when it struck the mailbox. After striking the mailbox, the vehicle departed northbound on McSmith Lane at a high rate of speed. Once the vehicle reached Little York Road, it turned east.

I asked Kaser if she knew of anyone who might want to harm her property and she said that she could not think of any. Kaser stated that she thought it was possible that the driver may have been retaliating against the owner of 7303 McSmith, but hit the wrong mailbox. Kaser stated that a resident, Tom Short, was recently evicted from 7303 McSmith.

I have no leads or suspects.
