On Monday, April 4, 2016 at 1626 hours, I was dispatched to Sam's Club in reference to a hit and run accident in the parking lot. Two unoccupied vehicles parked in a marked parking space were struck by a multi colored pickup truck bearing Ohio registration FRE9829.

Video footage showed the truck traveling west bound through the lot in row #8. Driver turned left into parking space and ran into the front of the parked vehicles, parked in row #9. The driver of the pickup truck then placed the vehicle in reverse and left the scene making no attempt to report the incident.

I went to the residence of the registered owner of the pick up truck located in Huber Heights, Ohio. The pickup truck was parked under a canopy in plain view in the driveway. I attempted contact at the front door and spoke with John H. Ballein. I explained to Mr. Ballein that I was their investigating a hit and run accident involving the truck in the driveway. Mr. Ballein explained he was driving the truck when the two cars were struck. He went on to explain that he panicked and that is why he left the scene. I told Mr. Ballein that panicking and leaving the scene was bad enough, but not reporting the incident in 24 hours after he had a chance to gather himself was ridiculous.

I issued Mr. Ballein citation #42062 charging him with Hit/Skip and told him he had a mandatory court appearance at Vandalia Municipal Court on Tuesday, April 12, 2016 at 0830 hours. Mr. Ballein signed and received his copy of the citation. The other parties received exchange forms containing Mr. Ballein's insurance information.
