



On Saturday, April 9, 2016 at 2007 hours, I was dispatched to the intersection of York Commons Boulevard and Towncenter Drive in Butler Township, Montgomery County, Ohio on the report of glass and debris in the roadway from a crash. The caller advised that they had observed two vehicles that were in the intersection that were in a crash, she described one as a car that was in the Walmart parking lot, and the other vehicle as being a red truck that had went to Petland and was no longer on scene.

Upon arrival, I observed glass in the roadway. I contacted Butler Township Fire Department to respond to assist in cleaning the glass from the roadway. I observed one of the crashed vehicles in the parking lot of Walmart. The vehicle, a 1997 Lexus, tan in color, bearing Ohio registration GQA5698, had heavy front end damage. The vehicle returned to a Michael J.C. Coleman at 2423 West Alex Bell Road.

I contacted the caller, Mackenzie Elam. Ms. Elam advised that a black male subject was driving the Lexus. She advised the vehicle had struck a red truck, driven by a white male, on the driver door. Ms. Elam advised she did not witness the actual crash occur.

I then made contact with Asset Protection Associate Chandler Johnson. Mr. Johnson advised there was a camera shot of the intersection. Upon review of the surveillance footage, at around 1950 hours, I observed the Lexus traveling westbound on York Commons Boulevard, not stop for the stop sign and strike the red truck, which appeared to be a Dodge, on the driver side door.

I observed the subjects get out of their vehicles, and then move the Lexus into the lot. I took photographs of the Lexus. Mr. Johnson provided me with a copy of the surveillance footage, and I included it with this report.

I had dispatch contact Regional Dispatch and obtain a phone number for Mr. Coleman. Dispatch made contact with Mr. Coleman, who provided the information for the driver of the truck, Ryan Enders. Mr. Coleman advised the subjects had exchanged information.

The truck was a 2012 Dodge Ram, red in color, bearing Ohio registration GBD3430. I made contact with Mr. Enders at his residence at 3068 Jewelstone Drive. He advised that he was in a crash from earlier and that information was exchanged. I informed him that due to the heavy damage a report was being completed. I took photographs of the damage to Mr. Enders' vehicle.

At around 1830 hours, I contacted Mr. Coleman and advised him that he was going to be issued a citation in regards to the crash. Mr. Coleman advised he resides at the address on West Alex Bell Road, but that he did not have a mode of transportation to meet with me and that he was not at his residence at the moment. I informed him to contact the police department upon his return to his residence.

The citation was sent to the Vandalia Municipal Court and marked as needing to be served.
