On Friday, May 06, 2016 at 0239 hours, I was dispatched to Walmart, 3465 York Commons Blvd, Butler Township, Montgomery county, Ohio, for a hit and run private property crash.

I arrived on scene and made contact with the on-duty Walmart manager Jennifer, who stated an employee had reported to her that a white Buick with Ohio registration GPL8015 Unit #1, had struck a parked white Pontiac with Ohio registration GIY8166 Unit #2 in row 11 of the Walmart parking lot. The employee was identified as Justin R. Barnett. Mr. Barnett further stated that Unit #1 was driving down the wrong direction in the lane, and attempted to pull into a parking spot next to the parked Unit #2 and struck the passenger side of Unit #2 with the drivers front of Unit #1. Unit #1 occupants then parked the vehicle in another spot, and went into the business.

The driver of Unit #1 was a younger possibly mixed female with a white shirt and jeans (picture attached from Walmart secure cameras.) The other occupants were two black females, one wearing pink and the other blue (refer to pictures and video attached.) The occupants never reported the accident to anyone and left the scene before my arrival.

I made contact with the owner of Unit #2, Leslee A. Smith, who was inside shopping at Walmart. She was advised of the damage and stated that no damage was previously there. I took digital photographs of the damage.

I later had Dayton Police make contact with the owner of unit #2, Jocelyn R. Cochran, at her registered address. They advised that Unit #1 was in the driveway, but did not see any damage. They provided me with a phone number and I contacted Ms. Cochran. She stated that she did not use her vehicle, but was unsure if a family member had, because she was sleeping. She stated that she did not see any damage, but would find out the next day if she knew who had driven it.

I was unable to make contact with Ms. Cochran until May 13, 2016. I conducted a follow-up with her at her listed address. I presented Ms. Cochran with the pictures from the security footage of the operator of her car, she stated it was a cousin, but did not remember her name. She stated that just wanted to handle the insurance claim herself and did not want to provide further information. She stated she would handle her family member using her car. I asked if the vehicle was stolen or an unauthorized use of a motor vehicle, and she stated no. I told that if it was she needed to report it to Dayton PD. She gave me her insurance information and still declined to make a family member responsible. I advised her that the insurance company would not accept this, and she stated that she would pay for the damages.

I noticed several rub marks on the front drivers bumper of her car (Unit #,) which would be consistent with the strike location from Unit #1 to Unit #2. Ms. Cochran stated that she did not recall that damage. I collected photos of the car and added them to the case.

I gave Ms. Cochran the information for Unit #2.

No further information is available.
