



On Wednesday, June 1, 2016, at 0934 hours, I was dispatched to 6108 Deerfield Street located in Butler Township, Montgomery County, Ohio, for a hit and skip property damage crash.

Upon my arrival at 0942 hours, I made contact with the reportee, Scott M. Ballard, who I identified via his Ohio Driver License, who gave me his report. Ballard stated that he operates a 2006 grey Chevrolet 1500 truck. The registered owner of the truck is Ballard's father, Michael D. Ballard. Scott stated that he parked the truck in front of his home located at 6108 Deerfield Street on Tuesday, May 31, 2016 at approximately 2145 hours. Scott continued that when he exited his home the next morning at 0920 hours, he discovered that the truck had been struck. I observed a broken left taillight on the truck as well as damage to the left rear quarter panel. There were blue paint transfers on the left rear quarter panel. Debris from the broken taillight was scattered along the street from immediately below the taillight to several feet in front of the truck. He stated that he did not hear any noises and had no idea the truck had been damaged prior to finding it. I took eight digital photographs of the damaged truck and the scene.

I examined the home near the crash scene and noticed a security camera located on the front of the home located at 6124 Imperial Hills Drive. I made contact with the homeowner and learned that the view captured by his camera ends in the middle of the intersection of Deerfield Street and Imperial Hills Drive and thus could not have captured the crash.

I obtained insurance information from Scott and departed the scene.

Later that day at 1401 hours, I was dispatched to 2400 Stop Eight Road located in Dayton, Ohio, which is a block away from 6108 Deerfield Street. Scott had been walking with his family and saw a blue Dodge Ram bearing Ohio registration GPK4178 with damage to its right front end. Believing it to be the vehicle that struck his parked truck, Scott called the police. Upon my arrival at 1412 hours, I observed Sergeant T. Stanley speaking with a white male and female. Stanley directed the female to speak with me. I identified the female as Heather Michelle Arnett via her Ohio Driver License. Arnett stated that she was driving the Dodge Ram on Wednesday, June 1, 2016 between 0300 and 0345 hours. She continued that she looked down at her phone while driving and hit the parked vehicle belonging to Scott. I obtained a sworn statement from Arnett to that effect.

Stanley took photographs of Arnett's vehicle, a blue 2001 Dodge Ram, which belongs to her husband, Nicholas E. Arnett. Stanley also took paint samples from the vehicle. I returned to 6108 Deerfield Street and provided Scott with a copy of the exchange of information sheet.

On Wednesday, June 1, 2016 at 1359 hours, I was dispatched to assist Officer B. Brown in reference to an evidence collection detail involving a Hit and Run crash that had occurred earlier.

I was dispatched to 2400 Stop Eight Road in the city of Dayton, Ohio adjacent to Butler Township. The victim, Scott Ballard had went for walk in his neighborhood looking for a vehicle that may have damage consistent with the damage left behind to his vehicle. Mr. Ballard found a 2001 Dodge Truck, blue in color, bearing an Ohio license plate of GPK4178. The vehicles color matched that of paint chips that were left at the scene, and paint exchange left on Mr. Ballards vehicle.

Upon my arrival, I met with Mr. Ballard. He pointed out the Dodge truck and the damage that was consistent in height, and correct to the side of the vehicle.

I went to the door and was met by the registered owner of the Dodge Truck, Nicholas Arnett and his wife, Heather Arnett.

At first both subjects denied the vehicle had been in a crash. I pointed out the damage and Mr. Arnett told me that he had no knowledge of a crash. I informed them that I had pieces and parts at the scene and paint transfer that I believed had come from their vehicle. I told them that I would impound the vehicle so that it could be processed as the suspect vehicle in the hit and run.

Additionally, I told them I would contact Krogers in Englewood, where Ms. Arnett claimed to have struck a vehicle and not reported it, all at once the Ms. Arnett spoke up and admitted that she was driving the truck last night around 0300 hours and looked down at her phone and struck Mr. Ballard's parked vehicle.

I took digital photographs of the Arnett's vehicle. I collected chipped paint from the damaged area of the right front fender.

Lastly, I returned to Ballard's residence and collected paint chips from the scene and plastic turn signal lens pieces.

The evidence will be forwarded to the crime lab for analysis.
