



On Wednesday, June 29, 2016 at 2202 hours, I was dispatched to 1918 Little York Road, Butler Township, Montgomery County, Ohio for a property damage crash.

Upon my arrival, I observed a silver Chevrolet Camaro parked facing east in the yard of 1918 Little York Road. The vehicle appeared to be unoccupied. There were several neighbors standing outside.
