



On Thursday, August 11, 2016 at 0908 hours, Officer C. Hammond and I were dispatched to Peters Pike at Little York Road in Butler Township, Montgomery County, Ohio on a two vehicle injury crash.

On arrival, I located the crash in the intersection of Peters Pike at Little York Road. In the intersection was a red 2008 Pontiac Grand Prix bearing Ohio registration GTQ1405 with heavy front end damage. The vehicle was occupied by a female driver, later identified as Starr M. Gray, and a small child that was in the back seat. Ms. Gray and her child were removed from the vehicle by BTFD medic personnel and subsequently transported to Miami Valley Hospital for further treatment.

Off the road at the southeast corner was a blue 2003 Chevrolet Trailblazer bearing Ohio registration DWG 1033 with heavy damage to the left side of the vehicle. The vehicle was occupied by a female driver, later identified as Natalie N. Jenkins. Ms. Jenkins was removed from the vehicle by BTFD medic personnel and subsequently transported to Miami Valley Hospital for further treatment. It should be noted that the fire department had to cut the driver's side front door so Ms. Jenkins could be removed from the vehicle.

While the drivers and passenger were being treated by the medic personnel, I spoke to three witnesses to the crash. I first spoke to Robert Wells and Rick Wells, who said they were in a truck stopped at the red light on northbound Peters Pike at Little York Road.

Both said that the driver of the red Pontiac Grand Prix was traveling southbound on Peters Pike and failed to stop for the red traffic light and struck the left side of the blue Chevrolet Trailblazer resulting in the Trailblazer going off the road at the southeast corner. Both Robert Wells and Rick Wells completed a written statement concerning the crash.

I next spoke to Montie Henderson, who said that he saw the red vehicle and blue vehicle collide, but he was unsure which vehicle had been traveling in which direction. He said he looked up at the time of the impact and did not see where the vehicles were prior to impact. Mr. Henderson completed a written statement concerning the crash.

Officer C. Hammond took photographs of the damaged vehicles and crash scene. Since both drivers went to the hospital, Busy Bee Towing towed both vehicles to their facility for safekeeping.

On Sunday, August 14, 2016, I arrived for duty and I had not received any information that either party involved in the crash had contacted the police.

At 0915 hours, I contacted Natalie N. Jenkins at her residence at 146 Lightner Lane in Union, Ohio. I obtained a written statement and insurance information from Ms. Jenkins. Ms. Jenkins said that she was traveling eastbound on Little York Road with the green light when she was struck in the intersection by a vehicle traveling southbound on Peters Pike.

Ms. Jenkins said that she was very sore from the crash and would be following up with her doctor on Monday for left arm pain and soreness.

At 0952 hours, I attempted to contact Starr M. Gray at her residence at 22 E. Alkaline Springs Road in Vandalia, Ohio. I received no answer at the door. I left my business card at the residence requesting Ms. Gray contact me about the crash.

On Wednesday, August 17, 2016 at 0530 hours, I received a message from Officer A. Harlow that she had contacted Ms. Gray at her residence. Officer A. Harlow issued Ms. Gray a citation for ACDA and obtained a written statement. Ms. Gray was given a court date of Tuesday, August 23, 2016 at 0830 hours at the Vandalia Municipal Court.

There was nothing further to report at this time.
