





On Tuesday, September 20, 2016 at 1712 hours, I was dispatched to 10880 Frederick Pike, Butler Township, Montgomery County, Ohio in reference to a hit and run crash.

Upon my arrival, I was met by Paul B. Putnam, who advised that he had witnessed the crash. He stated that a lime green SUV was traveling north on Frederick Pike and he was traveling south on Frederick Pike. He saw the vehicle leave the right side of the road, strike two mailboxes, come back onto the road into his lane and almost strike him head on. Mr. Putnam was able to turn around and catch up with the vehicle. He provided the Ohio registration of GME5615 and advised that he believed the driver was a white male.

I took photographs of the damage to the mailboxes. The mailboxes belonged to 10875 Frederick Pike (Eugene Brandenburg) and 10880 Frederick Pike (George Mooreman). Mr. Brandenburg was on scene at the time and I provided him with my business card and the report number. I was unable to make contact with Mr. Mooreman, I left my business card with report number in the mailbox on his residence.

I sent Brookville police to the registered owner's, Samantha Warman, address to make contact. They provided me her phone number and I made contact with her via public service. She advised that her boyfriend, Johnathan N. Evans, had her vehicle and he was at work. I advised her that I believed he had been involved in an accident with her vehicle and that I needed to speak with him. She said that she would have him call me.

On Thursday, September 22, 2016, I made contact with Ms. Warman again and she advised that Mr. Evans was with her. Mr. Evans' tried to deny being involved in the accident and eventually admitted that he had been driving the vehicle and lost control. He could not provide a reason for why he had left the roadway and stated that he wasn't aware that he had struck two mailboxes. He stated that he had lied about the accident and left the scene because he did not have a valid driver license.

I informed Mr. Evans that I would be issuing him a citation for driving under suspension and failure to maintain control. He stated that he understood and he would come to the police department on Friday, September 23, 2016 to be served the citation.

On Friday September 23, 2016 at 2100 hours, I made contact with Ms. Warman and she advised that Mr. Evans' friend who was bringing him to the police department was having issues with his vehicle and could not bring him. I advised her that I would be sending the citation to the Vandalia Municipal Court to be served to Mr. Evans.
