



On September 29, 2016 at 1338 hours, I was flagged down at the intersection of Maxton Road and North Dixie Drive, Butler Township, Montgomery County, Ohio in reference to a hit and run crash.

The complainant, Christopher M. Jones, advised that he was driving northbound on North Dixie Drive in the right northbound lane when an older model, dark green Buick ran the stop sign at Maxton Road and was struck by Mr. Jones. The vehicle, driven by a black male with dread locks, then fled southbound on North Dixie Drive.

Several witnesses stopped and provided witness statements, including one that followed the vehicle and was able to get the Ohio registration number, dealer plate 00D6ER.

I identified the dealer plate as belonging to Omega Auto Sales at 1613 N. Keowee Street, Dayton, Ohio. I made contact with the owner of Omega Auto Sales, Nebiyu Tesfaye(937-270-2282), who advised that the license plate had been lost or stolen several months before and that they had obtained a replacement from the BMV already. He advised that they did not file a police report because it was not uncommon for them to be lost or stolen. There were no additional leads involving the dealership.

I recognized the vehicle description as one I had seen leaving Days Inn after a theft complaint (16-062120), where a black female was refusing to pay for a room she had stayed in. Upon my arrival, the suspect was leaving in a vehicle matching the description of the hit and run vehicle, however, after speaking with the clerk, they advised the female had paid the bill before she left, therefore I did not make contact with her.

I made contact with the Days Inn clerk after the crash and obtained a copy of the folio from the theft call. The room had been rented to Shayla L. Harris, I requested that Trotwood check the address of Ms. Harris for the suspect vehicle, they advised that the vehicle was not at the residence.

There is no additional leads or information regarding this report.
