



On Sunday, January 8, 2017, at 1650 hours, I was dispatched to the Smashburger, located at 6731 Miller Lane, in Butler Township, Montgomery County, Ohio, for a private property hit skip crash.

Upon my arrival at 1655 hours, I made contact with the Unit #2 driver, Brandon P. Henson, who I identified from the LEADS photograph, while running the registration of a maroon Oldsmobile Alero bearing Ohio registration FZB5171, through the LEADS database. Henson had a passenger with him who I identified as Keith D. Greene via his Ohio Driver License. Both Henson and Greene gave me their verbal and written statements.

They stated that they were traveling from west to north in the parking lot in front of Smashburger, when a silver Pontiac, either a Grand Am or a Bonneville, bearing Ohio registration GOY6473 came from the north to travel west and struck the left side of the Alero, and departed west on York Commons Boulevard. Greene stated that the Pontiac contained two black males.

I asked how certain they were of the plate of the Pontiac, and they replied that another witness had seen the crash, saw the registration, and then approached them repeating "GOY6473" over and over again. I asked for them to point out this witness, and they stated that he had already departed the area. Henson stated that in the parking lot where the crash occurred were parts from the Pontiac. I located the parts, and I believe them to be two portions of a fog light assembly. I provided Henson my business card with the report number, retrieved his insurance information, and released him and Greene.

I ran Ohio registration GOY6473 through the LEADS database, and it returned to a silver Pontiac belonging to Priscilla L. Murray of 628 Groveland Avenue in Dayton, Ohio. I called the regional dispatch center and requested they send an officer to that address in an attempt to locate the vehicle and/or make contact with the owner.

Later in the evening, I called the regional dispatch center again, as I had not heard from anyone, and they reported that the officer had been unable to locate the car. I searched Murray through www.acurrint.com and learned that she had held another address of 2212 Germantown Street, which was also in Dayton, Ohio.

I called the regional dispatch center again and requested an officer to respond to that address in an attempt to locate the vehicle and/or make contact with the owner. Again, I received no response and recalled regional. Regional informed me that the officer had not been able to locate the car. Www.accurint.com also provided a phone number for Murray of (937)222-7010. I called that number several times throughout the evening of Sunday, January 8, 2017, but each time, I received a busy signal.

I called the number several times throughout the evening of Monday, January 9, 2017, but again, I only receive a busy signal each time I called. I looked in www.justiceweb.org and learned of a third address for Murray at 50 Pointview in Dayton, Ohio. I called the regional dispatch center and requested an officer go to that address in an attempt to locate the vehicle and/or make contact with the owner.

Dayton PD called and reported that the car was not at this address either. Www.justiceweb.org also had a jail contact for Murray. The contact was Angel Richardson at (937) 416-5485. I called that number, and a male answered stating that he did not know an Angel Richardson or Priscilla Murray.

Murray's car may be the hit/skip unit, but until it can be examined for damage to its front left, I cannot be certain it was the right car. I have no other leads at this time.
