



On Wednesday, 11/1/2017, we were dispatched to Great Clips, 6827 Miller Lane, for a report of a hit and run crash. Upon arrival, I made contact with Bryan Ogletree, a witness to the crash, who advised that a black Acura bearing Ohio Registration CVZ9140, backed out of a parking space in front of this address, striking into another vehicle that was parked in the lot. Bryan advised that he attempted to flag down the driver of the vehicle but he avoided him and did not stop.

Mr. Ogletree said the suspect driver of unit 1 was walking out of Great Clips as he was walking in. Mr. Ogletree pointed out the suspect vehicle had been parked facing the west, in front of the business. He demonstrated that the driver got in, backed up, and he heard a crash. He turned around to see the suspect driver had backed into unit 2's rear, which had been parked facing the west, on the row of spaces closest to Miller Lane.

Mr. Ogletree yelled, and waived, his hands, trying to get the driver's attention. The driver saw him as he stepped out in the lot. The driver then changed course, leaving the lot towards Miller Lane, avoiding contact with Mr. Ogletree. The suspect driver did not leave any required information before fleeing the crash.

We then made contact of the operator of the second vehicle, Steven Simpson, who advised that the male driving the vehicle was just inside Great Clips getting his hair cut. Someone had already written the information of the suspect down that he used to register for his haircut. The information showed "Ike Turner" with a phone number of "937-286-9295". We confirmed this with one of the clerks as being correct.

We returned to our cruiser and checked the given plate in LEADS. The plate did not belong to any registered vehicle. Due to the fact it was dark, and raining, Mr. Ogletree said he could have misread the plate. We contacted the listed phone number, and I learned from the person who answered that the number is new to him. He said he has had this number, on a cricket phone, for a couple weeks, and he does not know anyone named "Ike Turner". He also said he is having Facebook log-in problems due to the former owner still using this phone number on his account. He also said someone had already called him about the crash.

We returned to the store. I learned that Mr. Ogletree advised he was able to locate an Ike Turner on Facebook, and positively identified him by his photograph. He showed me the picture, and the account associated with "Ike Turner". I was able to take a picture of the suspect, and add it to this case. The link for his account is "https://www.facebook.com/ike.turner.988926". We also learned that the suspect had been claiming to have just been released from the Monday Correctional Center.

We photographed the damage to unit 2, which consisted of a scratch on the bumper, and the left rear bumper was popped out on the side. We obtained statements from Mr. Ogletree, and Mr. Simpson. We had to clear for an emergency call, and no further investigation was done, at that time. We will attempt to get video on a later date from the Great Clips store.

We then sent a faxed picture of the suspect to the Montgomery County Jail, in hopes of getting a lead as to the identity of the suspect. At this time, and until such time as leads are developed to identify the suspect, I respectfully request this case be considered suspended.
