



On Sunday, November 5, 2017, at 1953 hours, I was dispatched to the O'Charley's restaurant located at 7030 Miller Lane in Butler Township, Montgomery County, Ohio, for a single vehicle crash involving a Toyota Sienna minivan.

Upon my arrival at 1956 hours, I observed the van, activated my emergency lights, and pulled behind it. I exited the vehicle, observed that no one was inside the van, and was approached by an older white male. I identified that male as Ronald C. Jenkins. Jenkins advised that he too had struck an open man hole cover resulting in a flat tire. Jenkins continued that he was parked in the parking lot located at 7070 Miller Lane. I instructed Jenkins to return to his vehicle and wait while I completed the crash involving the Sienna and then I would assist him.

I walked to the man hole cover located south of O'Charley's in the northbound lane of Miller Lane. The cover was out of the hole and facing with the bottom up. A raised portion rose approximately four to six inches from the surface of the road. Water filled the man hole and some water was flowing out of the hole. Trash and other debris were around the area. The O'Charley's manager and I were able to lift the man hole cover and reinsert it into the hole right side up thus closing it.

A severe thunderstorm had hit the region dropping record amounts of rain throughout the Miami Valley. Throughout the evening I was dispatched to multiple motorist assists.

I completed the crash with the Sienna and arrived at 7070 Miller Lane and met with Jenkins at 2021 hours. Jenkins reiterated his initial report that he was traveling northbound on Miller Lane and as he approached O'Charley's he struck something and sustained a flat tire on the right rear. I did not observe any other damage to Jenkins' vehicle. I provided Jenkins with the crash report number. Jenkins informed me that he had an American Automotive Association tow truck en route to assist him.

I resumed patrol.
