



On Friday, November 17, 2017, at 0115 hours, Union PD Lt. Goudy advised over the radio that there appeared to be a pole struck in the area of 705 Martindale Road. He also advised that there was no vehicle at the location.

I proceeded to the area and I located the struck pole near 705 Martidale Road on the south side of the road. The pole had a severe vertical crack and the top electric line had been knocked loose. The wire was caught up in the other wires, and a portion of it was on the ground but off the roadway.

I advised dispatch to contact DP&L about the damaged pole. A few minutes later, dispatch advised that an employee was in the area looking for an electrical outage and would be enroute to my location. I met with the employee who said that the outage had been reported at 0053 hours on today's date by an unknown customer.

I examined the scene. The suspect vehicle had been traveling eastbound on Martindale Road and had gone off the right side of the road while negotiating the curve just west of 705 Martindale Road. The suspect vehicle traveled approximately 30 feet in the grass before striking the wood utility pole.

Based on the marks in the grass, the suspect vehicle backed up away from the pole before going around to the left of the pole and back onto eastbound Martindale Road. The suspect vehicle left the area headed east. Based on the tire tracks in the grass, the damage to the suspect vehicle would be to the center and right front areas.

I was not able to locate any vehicle debris, vehicle fluids, or other identifying information as to what the make and model of the vehicle was that struck the pole. There was some fine chunks of what appeared to be shattered vehicle glass on the roadway in the direction the driver fled. I took digital photographs of the scene and the damaged pole.

I checked the area, but I did not locate the suspect vehicle. At this time, there was no suspect information, and there were no known witnesses to the crash.

As of Saturday, November 18, 2017, at 0530 hours, no one had reported the crash to police and there was no additional information to determine the suspect. This case will be closed unless further information was obtained.

There was nothing further to report at this time.
