

On Monday, November 20, 2017, at 1830 hours, I reported for duty to investigate a series of hit and run motor vehicle crashes. These crashes were caused by the suspect who fled the Walmart parking lot immediately after he committed a theft offense. The series of crashes were captured on video by Walmart Asset Protection Associate, Cody Sanders.

I was able to review this video, along with Officer Ashworth's cruiser video, to assist me with this investigation. Upon reviewing the video, I noticed the following: At approximately 1715 hours, the suspect, Tylor Hamm, exited the store located at 3465 York Commons Boulevard. Hamm walked directly to a dark blue Chevy Trailblazer parked in isle #8 and got in.

A couple of minutes later, Officer J. Ashworth arrived and used his patrol vehicle to block Hamm and his female passenger in their parking space. As Officer Ashworth approached their vehicle on foot, Hamm drove around the patrol vehicle and headed south through the parking lot to aisle #7, where he made a sharp left turn and headed east toward the exit to Commerce Center Drive.

Hamm had the entire aisle open but suddenly made a sharp left turn and struck Sergeant Stanley's cruiser on the passenger side. Hamm stopped briefly but accelerated again toward the exit at a high rate of speed with Officer Ashworth in pursuit.

Hamm exited the parking lot without stopping at the posted stop sign, crossed over both lanes of travel on Commerce Center Drive, and went into the parking lot of the Hooter's restaurant, located at 6851 Miller Lane. Hamm was unable to control the vehicle and drove directly into a cinder block wall enclosure surrounding the dumpsters.

NOTE: Hamm's passenger was later diagnosed at Grandview Hospital with a lower leg (tibia & fibula) fracture, which most likely occurred due to this particular impact.

Officer Ashworth exited his patrol vehicle and attempted to break out Hamm's window to take him into custody. Hamm backed out of the parking lot and side swiped the passenger side of Officer Ashworth's patrol vehicle.

Hamm then fled south on Commerce Center Drive at an estimated speed of 60 mph in a posted 30 mph zone. Hamm ran the posted stop sign, as he entered the intersection at a high rate of speed, and he struck the rear passenger side bumper of a silver Hyundai Sonata.

Hamm continued south and ran the stop sign at Benchwood Road, as he made a right turn. Hamm would eventually crash a final time between two houses at the dead end of Autumn Ridge Road. Officer Ashworth apprehended Hamm after a short foot pursuit. This final crash was investigated by the Ohio State Highway Patrol.

Note: No traffic related violations will be cited until the felony charges against Hamm have been presented to the prosecutor's office for consideration.
