



On Monday, November 27, 2017, at 1403 hours, I was dispatched to Brunk's Meat Market located at 8634 North Dixie Drive in Butler Township, Montgomery County, Ohio, for a private property hit skip.

Upon my arrival at 1403 hours, I made contact with the complainant, Yvonne Hall, who I identified via her Ohio Driver License, and received her report. Hall reported that she parked her car, a tan colored 2009 Toyota Carolla bearing Ohio registration FBT1994, in the southern most portion of the parking lot in the second space from the signage adjacent to North Dixie Drive at the beginning of her shift.

Hall stated that around 1315 hours, she observed a red "Chevy S-10 sized" truck was parked adjacent to her car with a ladder in the cargo compartment and observed the occupants were attempting to remove the sign for the Layene Hair Braiding business from the signage. Hall stated that at 1345 hours, a coworker, Kaylin, arrived, entered the store, and asked if Hall's car had been hit. Hall exited the store observed some scrapes along the left side bumper of her car. The bottom most of the scrapes had what appeared to be a red hue to it. I took six digital photographs of the vehicle and scene. I asked Hall if she had seen the truck strike her car and she replied that she had not, but stated, "it had to be them as there is a piece of the sign next to my car." I observed a white colored piece of trim laying on the ground next to Hall's car. Hall's car was parked in the space at a slight angle with the front left tire over the line. I asked Hall if she knew where Layene's Hair Braiding was relocating to and she replied that she believe it was south on North Dixie Drive adjacent to the Living Room and a Speedway.

I drove south on North Dixie Drive and located the shopping center Hall described. There is another hair braiding business located at 3888 North Dixie Drive. I drove through the lot and did not see any trucks matching Hall's description. There was a red Ford Ranger in the lot. I examined the Ranger, but did not see any damage on the truck to suggest it was the hit/skip unit. I returned to Hall and informed her of my findings.

On Tuesday, November 28, 2017, I returned to 3888 North Dixie Drive and spoke with an employee. The employee, who spoke with a thick African accent, was uncooperative at best, but admitted that she had obtained help with the sign moving attempt and admitted that they were in a red truck. I asked if she knew the owner of the truck and she replied that she did not nor did she know the registration of the truck. The woman stated that she was parked multiple spaces away from the truck and stated that they were not anyway near any other cars. I left the woman my business car and requested that she contact me once she met with the truck owner so that I may inspect the truck for any signs of damage.
