



On Tuesday, December 12, 2017, at 1701 hours, I was dispatched to the Walmart located at 3465 York Commons Boulevard in Butler Township, Montgomery County, Ohio, for a private property damage hit/skip.

Upon my arrival at 1708 hours, I met with Steven J. Pfarrer, the registered owner of a black Chevrolet 1500 pick up bearing Ohio registration HFX9432, whose vehicle had been damaged while he was shopping inside of Walmart. The vehicle was parked in row 3 adjacent to the shopping cart corral nearest the store. I observed a small dent and rub on the driver's door. There was no paint transfer. I identified Pfarrer when I ran the registration through the LEADS database.

Pfarrer stated he arrived at Walmart at approximately 1550 hours and returned to his vehicle at approximately 1645 to notice the damage. Pfarrer stated that he had been at multiple places that day, but believed that the damage had occurred at Walmart. I took five digital photographs of the truck and scene.

I entered Walmart, but no asset protection associates were on duty.

On Wednesday, December 13, 2017, I returned to Walmart and spoke with asset protection associate Brooke Holliday and we reviewed security camera footage of the parking lot. I observed via security camera footage, a red Chevrolet pick up park adjacent to Pfarrer's vehicle and enter into the store. I then observed the white male driver exit the store, re-enter the vehicle and pull out of the parking space. I then observed the red Chevrolet back into the parking space and strike Pfarrer's vehicle. The collision occurred at 1642 hours. I then observed the red Chevrolet leave the parking lot. Neither I or the asset protection associate could make out the registration on the red Chevrolet. I took a photograph of the suspect vehicle.

I have no suspects or leads.
