On Tuesday, December 19, 2017 at 0546 hours, I was dispatched to the area of Martindale Road and Kley Road regarding a non-injury property damage crash in Butler Township, Montgomery County, Ohio.

Upon arrival, I met with a City of Union Police Officer that stated while patrolling the area, he discovered a red 2009 Pontiac Grand Am with Ohio license plate GHD6630 that had struck a utility pole after being ran off the road by another unknown vehicle. The occupants of the vehicle were not injured.

The driver of the vehicle Rachel Chrisman, stated she had just made the curve, and once driving straight and unknown vehicle was drove into the west bound lane forcing her to drive off the right side if the road. Mrs. Chrisman stated she did not see the utility pole when she drove straight into it. The passenger Levi Adkins confirmed the incident and he did not see the other vehicle do to the non-lighted roadway.

This area of roadway is not lighted and is very dark during the late night/early morning hours. The utility pole did not have a pole number and the pole was not damaged during the crash. Mrs. Chrisman and Mr. Adkins completed written statements regarding the crash. I photographed the damage to the vehicle.

Mrs. Chrisman stated she did not have an insurance card, however her father / owner of the vehicle would have the insurance card. Mrs. Chrisman stated she would contact me once she arrived home and provide me with the information. I provided Mrs. Chrisman my insurance card with the report number attached. As of Wednesday, December 26, 2017, I have not heard back from Mrs. Chrisman and I have not been able to make contact with her.

I did not issue a citation to Mrs. Chrisman for the crash do to being forced of the roadway. There were no other property damaged except her own vehicle.
