



On Friday, February 17, 2017 at 1032 hours, I responded to the Butler Township Police Department, located at 3510 Sudachi Drive, in Butler Township, Montgomery County, Ohio, in reference to a deer strike that occurred at 0530 hours on today's date.

Upon arrival, I met with Jerry Eberhard, who was the Transportation Manager for Clarion Inn Hotel in Englewood, Ohio. Mr. Eberhard advised me that his driver, Robert Hunt, struck a deer near the intersection of US 40 (West National Road) and Frederick Pike. Mr. Eberhard stated he needed to file a police report. I advised Mr. Eberhard that I would need to speak with Mr. Hunt, since he was the operator of the vehicle.

I spoke to Mr. Hunt on the telephone, and he stated that he was traveling west on US 40 (West National Road,) and when he crossed Frederick Pike, a deer ran out from the side of the road, and he struck the deer. Mr. Hunt said that he had picked up a pilot from the Dayton International Airport and was returning to the hotel in Englewood. I took several photographs of the damage to the vehicle, which I located possible hair from a deer on the passenger side door spring.

Mr. Hunt arrived at the police department at 1730 hours and provided a written statement. I asked Mr. Hunt if he had the name and phone number for the passenger, and he said no. Mr. Hunt advised that he only had one occupant in vehicle with him.

I contacted the Clarion Inn Hotel on Thursday, February 23, 2017 and they provided me the name of Adam Marco as the occupant in the van. The phone number that I was provided for Mr. Marco was 920-230-2080. When I called Mr. Marco, the phone number was no longer in service. I do not have any additional information at this time.
