



On March 8, 2017 at 0930 hours, I investigating a crash at the intersection of North Dixie Drive and York Commons Boulevard. Upon arrival I witnessed the two vehicles involved in the crash.

Unit#1 a tan Chrysler Concord was reported by the two drivers to be traveling north on North Dixie Drive in the left through lane. Unit#2 was a white Chevrolet Malibu reported by the drivers as traveling south on North Dixie Drive in the left turn lane in the process of turning left onto York Commons Boulevard.

The driver of Unit#1 states he had the green light and Unit#2 turned in front of him. Unit#2 states that Unit#1 ran the red light while she was clearing the intersection she had already established.

With the conflicting statements I resulted to witnesses to see if they could confirm either story. At the scene three witnesses in cars on York commons were approached. The first two cars in the left turn lane on York Commons Boulevard left their names and numbers. The third witness in which I received a written statement at the scene had verbally told me two conflicting accounts of the accident before writing her statement. First story was that Unit#1 was traveling south on North Dixie Drive and struck Unit#2 which was traveling north on North Dixie Drive making a right turn and was struck by Unit#1 who was turning left. Second account was Unit#1 and Unit#2 both were traveling north on North Dixie Drive, Unit#1 in the left lane and Unit#2 in the right turn lane when unit#1 struck Unit#2 when both units made a right turn onto York Commons Boulevard. No account of the light turning red prior to Unit#2 clearing the intersection. I was able to get one of the two witnesses to return a phone call and was told they could not clearly give an account of what had happened.

So based on the fact of conflicting statements by the drivers I can not determine if Unit#1 ran the red light or if Unit#2 failed to yield while turning left. I can not go on the statement of the witness at the scene because her account of the incident was and is ever changing, conflicting now with the two drivers involved in the accident. I know that parties affiliated Unit#2 has spoken with the witness in which she has reported further accounts that were not reported at the scene in her statement.

On March 20, 2017 around 1134 hours, I returned a request to call Michael Whittington. Mr. Whittington contacted dispatch trying to make contact with me. Our conversation started by Mr. Whittington expressing his views of unit# 2's statement. Mr. Whittington said he was accused of drinking and he did not and does not drink. I told Mr. Whittington at the scene no odor of alcohol was detected and no test were requested therefore the under the influence was not an issue. As Mr. Whittington spoke he mentioned he had saw the yellow light at the cross walk. I told Mr. Whittington his statement said he had the green light with no mention of the yellow light. Mr. Whittington said that he began to stop then pushed the gas to go through the intersection. I then asked Mr. Whittington if he could explain the continuous skid mark left behind from his tires 20 yards back south of the stop line leading to the point of impact, if he slowed and then accelerated attempting clear the intersection. Mr. Whittington could not answer the question. Based on the consistent statements of Unit#2, a verbal statement at the scene by independent witness stating unit# 1 ran red light, Mr. Whittington's new account of the incident and evidence I cited Unit#1 for running the red light.
