

On Saturday, March 18, 2017 at 0123 hours, I was dispatched to Wings Bar and Grille, located at 7902 North Dixie Drive, in Butler Township, Montgomery County, Ohio, on a hit and run crash that just occurred.

According to the dispatch, a bar patron witnessed a a maroon Toyota 4Runner, bearing Ohio registration GVA3624, back into a truck bearing Ohio personalized plate BIGWAT. The driver of the 4Runner fled the scene northbound on North Dixie Drive.

On arrival, I spoke to Aaron A. Watson, who was the owner of the struck truck. Mr. Watson said that he was an employee of Wings, and he was inside the business when the crash occurred. Mr. Watson said that patron came inside and told him his vehicle had been backed into.

I examined Mr. Watson's vehicle and there were scratch marks across the front bumper area. There was no paint transfer and there were no vehicle parts located at the scene. I took 3 photographs of the damaged area.

I ran the suspect vehicle's registration through LEADS and found that the plate returned to a maroon 1994 Toyota 4Runner belonging to Tambra D. Brothers. Ms. Brothers's address off the registration was 336 North Dixie Drive Apt 2 in Vandalia, Ohio.

I contacted dispatch and requested they contact Vandalia PD to see if they could locate the vehicle or make contact with the registered owner. At about 0200 hours, VPD reported that the vehicle had been located at the registered owner's address.

I went to the address and there was no answer at the residence. I attempted to contact Ms. Brothers using a phone number from a previous report, but it went to voice mail. I left Ms. Brothers to contact me about the crash.

I took photographs of the rear of the 4Runner. The bumper and tow receiver were very rusted. I saw no obvious paint transfer, and there appeared to be no fresh damage to the vehicle.

At about 0800 hours, I spoke to Ms. Brothers on the phone. Ms. Brothers said her son, Brandon Fields, had her vehicle while she was at work. Ms. Brothers said she did not think that Brandon went to Wings. I requested she speak to her son to find out what happened and to call me back.

At about 2230 hours, I spoke to Ms. Brothers by phone. Ms. Brothers changed her story and now said she probably bumped another vehicle while at Wings. Ms. Brothers said she had State Farm insurance but could not find her policy number.

I later provided Mr. Watson a copy of the exchange of identifying information form. Mr. Watson said he looked at his damage in the daylight, and it appeared that there were only superficial scratches to the clear coat on the vehicle.

There was nothing further to report at this time.
