



On Sunday, March 19, 2017, at 2325 hours, I was dispatched to the intersection of Meeker Road and Heathcliff Road in Butler Township, Montgomery County, Ohio, for a hit and run crash with no reported injuries. The caller advised the suspect vehicle, a small white car, left the scene west on Heathcliff Road towards Main St. The caller further stated the vehicle would have damage to the front passenger side of the vehicle. I advised dispatch to contact Clayton PD and Englewood PD about the suspect vehicle.

I arrived on scene and made contact with the operator of a Silver 2005 Saturn SUV with Ohio registration DOX2387 (Unit #2.) The vehicle had damage to the front passenger side bumper area. I identified the owner/operator as Gerald C. Lang, who stated he was traveling east on Heathcliff Road, and when at the Meeker Road intersection he stopped at the posted stop sign. Mr. Lang advised that he noticed a white sedan (Unit #1) traveling south on Meeker Road towards the intersection at a high rate of speed. Mr. Lang advised that vehicle traveled through the intersection, failed to stop, and when at the middle of the intersection attempted to travel west from its south position. The vehicle struck Mr. Lang's vehicle, which was still stopped on Heathcliff at the stop sign.

Mr. Lang advised that Unit #1 had struck his vehicle with its front passenger side into his vehicle front passenger side. He pointed to the area of the crash location and to the debris that was collected near the stop sign that was associated with his stopped location. He advised that Unit #1 then reversed the vehicle and headed west on Heathcliff Road toward Main St. He advised that he believed it was a white male in his late 30's or 40's.

Mr. Lang and I walked to the debris location nearest the stop sign, and I noticed an orange turn signal reflector in the roadway. I compared it to his vehicle and noted that it was not from his vehicle. Mr. Lang advised that it was not his. Mr. Lang then pointed to another debris pile that was a short distance northeast of stop sign. Mr. Lang advised that this was the location that Unit #1 had reversed to and had placed his vehicle in drive to leave the scene.

I photographed the scene and turn signal reflector, which I collected as evidence, and later booked in as evidence at the police department.

While still at the scene, dispatch advised that Clayton PD had located a white 2008 Mercedes sedan with Ohio registration 748YZG, in the Stoneridge housing complex parking lot on Rustic Oak Dr Dayton, OH 45415, which was less than a mile west of the crash location off of Heathcliff Road before Main St. Sgt. Morgan arrived at my crash location and advised he would meet with the Clayton Unit. I handed him the turn signal reflector to compare. Refer to his supplemental report for further.

I later arrived on scene, and Sgt Morgan advised that the turn signal reflector did match the missing one from the passenger side of the Mercedes. I looked at the Mercedes and noted that the damage was on the front passenger side of the vehicle, and that the turn signal reflector was missing. I compared the turn signal reflector to the left turn signal reflector ,and it appeared to match.

The vehicle returned as registered to a James E. Stefanoff, who lived at 687 Rustic Oak Dr. The car was parked in a parking spot very near to the registered address. I attempted to contact Mr. Stefanoff but received no answer. The listed phone number for him (937-576-0334,) but it appeared to be incorrect.

I made several more attempts throughout the next day, and I did not receive any response. I advised day shift Officer Brown to attempt to contact Mr. Stefanoff at his house. Officer Brown advised that he was not able to make contact either. I left a business card at Mr. Stefanoff's residence to contact me in reference to this case.

On March 22 I received a call message from dispatch advising that Mr. Stefanoff had called, refused to give his current phone number, and advised that all questions in reference to this case were to be
