



On Saturday, April 1, 2017 at 0534 hours, I was dispatched to 7791 Peters Pike in Dayton, Ohio, regarding a one car crash with the driver trapped inside the vehicle.

Upon arrival, I observed a dark blue 2004 Chevrolet Tahoe with Ohio license plate number DDL8818 sitting in a culvert that contained a low level of water. The vehicle had excessive front end damage from striking a fire hydrant and a culvert pipe. The vehicle had struck the culvert pipe straight on.

Inside and outside the vehicle, there were bundles of newspapers that were still strapped together. It appeared the driver was a newspaper delivery driver for Dayton Daily News. While inspecting the vehicle, I located the fire hydrant under the left front side of the vehicle.

During my investigation, I did not locate any skid marks from the vehicle on the roadway. It appeared the driver drove left of center and into the culvert on the west side of the roadway. The driver had struck the fire hydrant before he drove into the culvert pipe.

The driver/owner of the vehicle, Richard Dixon (75 years of age,) was trapped inside the vehicle and was partly under the dashboard. Mr. Dixon was extracted by Butler Township Fire Department crews by mechanical means. Mr. Dixon was transported to Miami Valley Hospital by Butler Township Medics with non-life threatening injuries per Butler Township Medics, however, he was listed in serious condition. I was unable to speak to Mr. Dixon due to his medical condition at the scene.

I was not able to collect any emergency contact information for Mr. Dixon at the time of the crash. Mr. Dixon's vehicle was towed by Busy Bee Towing. Due to the condition of the vehicle, the excessive amount of news papers, and the amount of blood inside the vehicle, I was unable to inventory the vehicle.

On April 2, 2017, I responded to Miami Valley Hospital in the attempt to make contact with Mr. Dixon in room 4417. Mr. Dixon was admitted to the hospital on April 1, 2017 and was placed in a private room in the trauma unit area of the hospital. I was at his room for approximately 30 minutes in the attempt to make contact. I was advised that Mr. Dixon was heavily medicated and was being made comfortable to due his excessive pain. I was unable to speak to Mr. Dixon or receive any information on his condition. Mr. Dixon had no family visiting at the time I was there, and no family had been to visit Mr. Dixon per the nursing staff.

I was able to collect emergency contact names for Mr. Dixon. I was advised the only family listed for Mr. Dixon was his elderly parents, Richard Dixon 937-321-2618 and mother Judy Dixon 937-276-9247. I had not been able to make contact with his parents with the phone numbers that were provided by the nursing staff.

As of April 7, 2017, I still had no information regarding the cause of the crash, insurance information, a phone number, or a current address for Mr. Dixon. It was unknown if the crash was caused by a medical condition, he fell asleep, or there was a mechanical issue with the vehicle. There was no indication that he was intoxicated. There was no odor of alcoholic beverage inside the vehicle at the time of the crash and there were no alcoholic beverages seen inside the vehicle. There were no other vehicles involved in the crash, and no witnesses to the crash as it happened.

No citation will be issued to Mr. Dixon due to the circumstances regarding the incident and not knowing the actual cause of the crash. No other victims were involved in the crash.
