



After the initial collision, unit #2 and unit #1 were both forced into the yard of 7595 Dog Leg Road causing damage to the yard. The vehicles also ran over a stop sign for westbound Meeker Road at Dog Leg Road, which would later be repaired by Montgomery County Engineer employees since it was destroyed.

The driver of Unit #2 sustained cuts and injuries that caused him pain when standing. Unit #1 driver sustained bruising and soreness, but no visible injuries. She was transported to the hospital by the Vandalia Fire Department. The driver of unit #1 did not know what happened and said she was lost trying to go to Clayton. Unit #2's driver said he saw Unit #1 fail to stop at the stop sign, and he could not react in time to avoid a collision. I did not obtain statements as both drivers were being treated at the hospital. I instructed both to contact me after they were released.

On Thursday, April 14, 2017, at approximately 1400 hours, I met with unit #1's driver, Mrs. Smith, at the Cracker Barrel restaurant on Miller Lane. She provided proof of insurance and confirmed she only had bruising and was sore. I issued her a citation for running the stop sign, and she understood the court appearance procedures. I did not obtain a written statement from her since she said she did not know what happened, as it happened so quickly.

As of Saturday, April 15, 2017, Unit #2's driver, Mr. Masango, had not contacted me regarding this crash. I am submitting the crash due to reporting requirements, and it should be noted I had not seen Mr. Masango's proof of insurance or obtained a written statement.
